TRAINING WITH TIM DOG TRAINING

- 1. Lessons need to be paid in full on or before the time of the first scheduled session or group class sessions.
- 2.Full refunds for individual sessions or classes will be given if the request is received 24 hours **before** the session/class start time. For group classes, after the first class session, 50% of the total paid may be refunded as long as it is requested before the second class session. No refunds will be given for requests received after the second scheduled class takes place.
- 3. One make-up class may be arranged with notice at the time of payment. Make-up classes are not typically available for missed classes.
- 4. If your dog is sick, please do not bring them to individual sessions or group class. If you have a question about what is allowed in class, please contact the instructor. You are encouraged to come to sessions to see what is covered with your dog on that particular day.
- 5. Dogs in heat are not allowed to attend class as it is a distraction to other dogs.
- 6. In the group class setting, instructor reserves the right to remove dogs from the training area who show aggression towards people or other dogs. Private sessions may be recommended in these cases. Please be sure to disclose any aggressive tendencies that your dog may have to the instructor **prior to** registering.
- 7. Dogs must be on leash at all times.
- 8. Dogs are not allowed to meet before, during, or after class unless granted permission from the head instructor.
- 9. Because small children may be at an increased risk of injury and/or may be a distraction to the owner/handler, children under 12 may attend class with separate adult supervision and may not handle dogs during training class.
- 10. Owners must provide proof of up-to-date vaccinations for their dog prior to the first class. Any dog that does not have up-to-date shots or fails to provide the appropriate documentation will not be allowed in class. If the owner does not provide approved documentation by the second class, they will forfeit their registration fee.
